POLICY ENHANCEMENT INITIATIVES (THROUGH CIDA / IBM / PWC)

As part of the Oil and Gas Sector Programme Pakistan, I developed a large model of the Pakistani economy. This model was developed with the close cooperation of members of the Ministry in Islamabad. The objective of the model was to inform policy makers of the "predicted impact" that *changes in energy policy* would have on the economy, both at the aggregate level and the sectoral level. A very rich specification of domestic energy policy was modeled – *from price regulation, subsidies, and factors that affect supply*. There was also an extensive analysis on substitution across energy sources, and implications for the environment. The model is currently being used in the Ministry as an additional tool to guide the optimal design of energy policy. I have also assisted in the financial and economic analysis associated with the development of energy resources, as well as the financial and economic implications of policies that encourage use of one form of energy relative to another.
